**RELEASE OF LIABILITY, ASSUMPTION OF RISK, AGREEMENT TO INDEMNIFY AND NOT TO SUE FOR MINORS PARTICIPATING IN REDWOOD CITY GIRLS SOFTBALL LEAGUE PROGRAMS**

I hereby give my consent for the named minor to participate in the Redwood City Girls Softball League (RCGSL).

I understand that the minor's voluntary participation in the Redwood City Girls Softball League involves potential risks of injury, both serious and minor, including but not limited to head or other injuries, loss of sight, broken bones, brain damage, paralysis and death.

Individually, and as parent or legal guardian of the minor, I hereby certify that I know the minor's state of health and well-being and that the minor is physically fit to participate in the Redwood City Girls Softball League and that I am unaware of any medical condition which might make the minor's participation inadvisable.

Individually, and as parent or legal guardian of the minor, I hereby acknowledge my responsibility to acquire health insurance coverage sufficient to provide for any and all medical or dental services related to injuries, both serious and minor, arising out of or connected with the minor's voluntary participation in the Redwood City Girls Softball League.

Individually, and as parent or legal guardian of the minor, I hereby release and discharge the Redwood City Girls Softball League, it's Board of Directors, officers, agents, sponsors, volunteers, students, and employees, who through negligence or carelessness, might otherwise be liable to me, the minor, our heirs, personal representatives, relatives or assigns from any and all liability associated with, arising out of, or related to the minor's participation in the Redwood City Girls Softball League including all liabilities associated with and any and all claims that may be filed on behalf of or for the named minor.

Individually, and as parent and legal guardian of the registered player, I hereby agree and confirm to the Redwood City Girls Softball League that the registered player will not participate in any other girls softball recreational, travel or competitive programs during the season for which the registered player is registered. Without limiting the foregoing, this means that if my daughter is registered for the Redwood City Girls Softball league Spring league program, she will not participate in any other recreational, travel or competitive girls

softball programs during the Spring season.

As parents/guardians, it is your job to set the tone of the behavior that is exhibited by your children both off and on the field. The Redwood City Girls Softball League will be enforcing extremely stringent policies with regard to both coach and parent behavior. Your job as a spectator is to cheer for your child and their team and to let all coaching be handled by their coach. Please understand that this policy extends to you, as parents/guardians, as well as any guests that may be on the sidelines or stands. Negative comments to your own child, a teammate of your child's, the opposing team, or the umpires will not be tolerated in any capacity; violators will be asked to leave the field immediately, and repeat offenders may be banned from games.

Individually, and as parent or legal guardian of the named minor, I hereby acknowledge that the named minor is the age I specified during the registration process, otherwise the player will face disqualification.

**RCGSL cannot reschedule games to work around personal schedules or schedules of other groups, organizations or sports leagues. Many schools and other organizations schedule various trips and activities throughout the softball season. The RCGSL season will begin with opening ceremonies on March 3, 2012 and will end with final games and playoffs on May 19, 2012. These dates are set and cannot be changed. Please, check your calendar before signing up.**

I am of legal age and voluntarily agree to this release of liability, assumption of risk, agreement to indemnify and not to sue.

Requests for 2012 Spring League refunds must be made to the RCGSL Registrar through regular mail or email by January 11th, 2012. All refund requests will be subject to a \$25 administrative fee, including those using the partial payment plan. No refunds will be granted after January 11th, 2012.
